AN ORDINANCE AMENDING TITLE 2, ADMINISTRATIVE CODE,
OF THE MIDVALE MUNICIPAL CODE

WHEREAS, the City Council desires to amend Section 2.12.040 the Midvale Municipal Code to reflect the current salaries of the Mayor and City Council as adopted in the FY 2013 budget; and

WHEREAS, the City Council finds it in the City's best interest to amend Title 2, Administrative Code, to comply with Utah State Code and provide a cohesive municipal code; and



Chapter 2.12 MAYOR AND CITY COUNCIL

Section:
2.12.040 Compensation of Mayor and City Council.

2.12.040 Compensation of Mayor and City Council

A. Each member of the City Council, other than the Mayor, shall be paid an annual salary of ten ~~eight~~ thousand dollars. The Mayor shall be paid an annual salary of sixteen ~~fourteen~~ thousand five hundred dollars and an annual car allowance in the amount of three thousand dollars.

B. In addition to the salary paid the elected officials shall be authorized to receive health and dental benefits at the same level as City employees.

C. In addition to all other compensation or salaries, elected officials may receive travel expenses and per diem established by the City for attending any meeting, conference, seminar or training session, provided attendance shall have been approved by the governing body.
