ORDINANCE NO. 2012-14

**AN ORDINANCE ADOPTING TITLE 11 OF THE CODE OF ORDINANCES
OF SALT LAKE COUNTY PERTAINING TO VEHICLES AND TRAFFIC**

WHEREAS, Section 10-8-84 *et seq.*, Utah Code Annotated, 1953, as amended, grants the authority to municipalities to enact ordinances that are necessary and proper to provide for the safety and preserve the health, and promote the property, improve the morals, peace, and good order, comfort and convenience of the City and its inhabitants; and

WHEREAS, the regulation of vehicles and traffic is necessary to provide for the good order of the City; and

WHEREAS, Midvale City contracts with Unified Police Department (“UPD”) for police services and UPD occasionally uses Salt Lake County Traffic Code for vehicles and traffic enforcement.

WHEREAS, Midvale City Council hereby concludes that it is necessary to adopt Salt Lake County’s Title 11 pertaining to vehicles and traffic enforcement to allow UPD to use Title 11 of Salt Lake County Traffic and Parking Code; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the Midvale City, Utah as follows:

SECTION I

That Salt Lake County’s Code of Ordinances, Title 11 pertaining to vehicles and traffic be adopted and enacted as set forth in Exhibit “A,” attached hereto, and incorporated herein for all purposes.

SECTION II

That Midvale City shall use the fee schedule currently in use by the Midvale Justice Court.

SECTION III

In the event that any provision of newly adopted Title 11 is declared unconstitutional, illegal or void, the remaining provisions shall be separate and remain in effect until similarly ruled as such.

SECTION IV

This ordinance shall become effective upon passage, signature and notice of passage published in a newspaper of general circulation.
